## **Instructions for Candidates**

- The Examination Fees and other payments should be paid to any branch of the Hatton National Bank
  (A/C NO 063020073300). Please refer to the Notice "Payment of Fees Via Banks", which is posted
  on our website on February 26, 2024.
- The total Examination Fee payable is as follows:
  - For students who registered before January 05, 2023: **LKR 1,000** per subject into the number of subjects in the Preliminary, Intermediate or Final Examination.
  - For students registered after January 05, 2023: **LKR 2,500** per subject into the number of subjects in the Preliminary, Intermediate or Final Examination.

- Students who have submitted withdrawal forms or medicals for not sitting the examinations, must pay the following fees:
  - Withdrawals based on medicals :
    - For students who registered before January 05, 2023: Entire exam fee + LKR 500
    - For students registered after January 05, 2023: Entire exam fee + LKR 2,000
  - Withdrawals not based on medicals :
    - For students who registered before January 05, 2023: Entire exam fee + LKR 1,000
    - For students registered after January 05, 2023: Entire exam fee + LKR 5,000

- Foreign LL.B graduates who failed to pay the lecture fees for the Intermediate or Final Year must pay:
  - If he or she registered before January 05, 2023 :
    - ➤ Intermediate Year LKR 15,000
    - Final Year LKR 19,500
  - If he or she registered after January 05, 2023:
    - ➤ Intermediate Year LKR 40,500
    - Final Year LKR 55,500
- The renewal registration fee applicable where necessary:
  - For students who registered before January 05, 2023: LKR 2,500
  - For students who registered after January 05, 2023: LKR 15,000
- Optional Subjects once selected cannot be changed.
- Please print the application on an A4 paper on both sides.

You can drop your application between **February 26 – March 11, 2024** in the box kept at the reception of the Law College building (payment must be made prior to this). Late applications will be accepted from **March 12 – 18, 2024**, subject to the late payment fee of LKR 15,000.
