The mandatory English Language requirement to sit the following subjects in the October 2022 (starting in December 2022) examination

- Legal History and Legal Systems,
- Criminal Law and
- Industrial Law

WILL NOT APPLY to candidates:

1. who have sat all eight (8) subjects in the October 2021/April 2022 Preliminary Year Attorneys-at-Law Examination either in Sinhala or Tamil medium and failed. i. e. a student who will be repeating the preliminary year examination; or
2. referred and re-referred to sit the examination in October 2022.

If you are eligible for this concession, please fill out the form attached to this Notice and email it to principalsoffice@slc.ac.lk on or before Monday, November 28, 2022, by 11.00 p.m.

This concession **WILL NOT APPLY** to:

1. candidates who have withdrawn from the October 2021/April 2022 Preliminary Year Attorneys-at-Law Examination.
2. candidates who are repeaters or referred from any previous examination other than October 2021/April 2022 Examination.
3. candidates who have not registered for the October 2021/April 2022 Examination.
4. Candidates who have not applied to sit for October 2022 Examination

IMPORTANT

5. This concession **WILL ONLY BE** applicable for the students who are sitting for the October 2022 (starting in December 2022) examination under the above-mentioned criteria and **NOT** thereafter.
6. This concession **WILL NOT BE** applicable for a candidate repeating Preliminary Examination at an examination after December 2022. (*viz.* April 2023)
7. This concession **WILL NOT BE** applicable to repeaters and referred candidates who are sitting Intermediate Examination in October 2023.
8. **The provisions of the Ex-Gazette 2208/13 dated 30.12.2022 will strictly be applied in all examinations held after December 2022.**
