# General Entrance Examination 2022 Admission of students for academic year 2023 (January)

Sri Lanka Law College is inviting applications from eligible candidates to sit for the General Entrance Examination 2022. This examination is held for the admission of students to Sri Lanka Law College for the <u>Academic Year 2023 (January).</u>

All relevant information is ONLY available in this website. An eligible candidate can submit an **ONLINE APPLICATION** (only one application) between September 15, 2022 and October 16, 2022.

An eligible candidate MUST have the following entry requirements to sit for the General Entrance Examination.

- (a) Two credit passes and one simple pass (except General English and General Knowledge subjects) at one and the same sitting at the Sri Lanka General Certificate of Education (A/L) Examination; and
- (b) Credit passes in English Language AND Sinhala / Tamil Language at the G.C.E. (O/L) or N.C.G.E. Examination; and
- (c) Applicants should have completed seventeen years of age at the date on which submission of applications close.

# **ENTRANCE EXAMINATION**

All applicants must sit for the General Entrance Examination to be held ONLY in **Colombo** on **November 20, 2022**.

The question papers for the Examination are as follows:

- 1. Language Skills
- 2. General Knowledge and General Intelligence

The link for the past question papers will be sent to the applicant's email.

# SUBMISSION OF APPLICATION

The application is only available online. Duly completed application must be submitted *via* online on or before October 16, 2022 23:59hrs (UTC+5:30) Sri Jayawardenepura.

Application fee is LKR 6,000.00

If the candidate elects to answer the General Knowledge and General Intelligence Paper in either the Sinhala Language or the Tamil Language, the candidate should elect to sit for the English Language Paper. If the candidate elects to answer the General Knowledge and General Intelligence Paper in the English Language, the candidate should elect to sit for either the Sinhala Language or the Tamil Language Paper.
