

Special Notice on Attorneys-at-Law Examination
2021 October/2022 April
Please read this guideline/instructions carefully.

Rescheduled Examination will commence on July 04, 2022. See attached timetable.

Submission of Exam Application for the Rescheduled Examination

1. The students who **could not apply** on or before March 14, 2022 for the examination commenced on May 09, 2022, but have fulfilled the eligibility criteria to sit for that examination, could apply to sit for the Rescheduled Examination by uploading the form – "Submission of Exam Application" *via* the following link between **08.00 a.m. June 06, 2022 and 3.00 p.m June 07, 2022.**

2. The candidates who had applied for the Rescheduled Examination (commenced on May 09, 2022) on or before March 14, 2022, are **not required** to apply.
3. Students who intend to sit for the Rescheduled Examination are required to [download](#) the relevant Examination Application Form (please print the application on A4 size paper on both sides) from the Sri Lanka Law College website www.sllc.ac.lk. The duly filled applications are requested to upload *via* the above link (point one (1) above).

Issuing of Admission Forms

1. Admission forms for all candidates will be re-issued by the Law College for the Rescheduled Examination *via* email (those who have applied by March 14, 2022, and those who intend to apply anew for the Rescheduled Examination).
2. All candidates must bring the printed admission with them to sit for the exam. Please check your new examination center, it may not be the same center allocated to you for May 09, 2022 examination.

Industrial Law Paper – March 09, 2022

1. The candidates who faced the Industrial Law paper on May 09, 2022, will be given an opportunity to re-sit the Industrial Law paper on July 04, 2022. If any student wishes to re-sit Industrial Law paper he/she is required to upload the form "Re-Sit Application (Industrial Law)" *via* the link <https://forms.office.com/r/vQmFUAgRL8> on or before 3.00 p.m. June 07, 2022,
2. If any candidate fails to submit the Re-sit Application (Industrial Law) form, their examination answer script on May 09, 2022, will be assessed.

Submission of withdrawal form

1. Any withdrawals previously submitted will not be considered as valid.
2. The candidates who do not wish to sit for the Rescheduled Examination can withdraw from that examination by uploading the form – "Submission of Exam Withdrawal Form" via the following link on or before **3.00 p.m. June 26, 2022**. This is the **ONLY** mode of withdrawal. Any methods other than this will not be accepted.

3. Any candidate who does not withdraw from the Rescheduled Examination will be considered as a student intending to face the examination beginning on July 04, 2022.

Submission of Medical Certificate

1. Any previously submitted medical certificates will not be considered as valid.
2. Any candidate who fails to sit the Rescheduled Examination due to any medical reasons must submit their medical certificates with supporting documents to the Law College on or before the last date of examination.

Payment of Fees

1. Students who already paid for the examination (commenced on May 09, 2022) on or before March 14, 2022, but have withdrawn, given medicals or absent from that examination are not required to make any payment for the Rescheduled Examination on July 04, 2022.
2. The students who intend to sit for the Rescheduled Examination are required to pay the Examination Fee on or before 3.00 p.m. June 07, 2022. Follow the published notice on February 18, 2022.
3. If the student has not paid the renewal and/or lecture fees, he/she is required to pay all such payments in arrears by 3.00 p.m. June 07, 2022. Please enter the details of the payment code correctly.
4. Foreign LL.B Students who have not paid the lecture fees for the Intermediate/Final Year, have to pay Rs.15,000/- (intermediate) or Rs.19,500/- (Final) and Renewal Fee is Rs.2500/- per year where applicable on or before 3.00 p.m. June 7, 2022.
