Mahapola Higher Education Scholarships 2024/2025 – General Entrance Batch

Mahapola Higher Education Scholarships will be awarded to eligible students who have gained admission from the Sri Lanka Law College General Entrance Examination held in 2024 for the 2025 academic year. There are two scholarships.

(1) Merit Scholarship:

The applicant should fulfill the following criteria:

- 1. Age should be less than 24 years, as of January 01, 2025
- 2. Should not be recipients of the above scholarship from any University or Higher Education institute previously
- 3. Should not be employed during the scholarship period
- 4. Should have obtained high marks in the 2024 General Entrance Exam

(2) Ordinary Scholarship:

The applicant should fulfill the following criteria:

- 1. Age should be less than 24 years as at January 01, 2025
- 2. Should not be recipients of the above scholarship from any University or Higher Education institute previously
- 3. Should not be employed during the scholarship period
- 4. Parental annual income should be less than or equal to Rs. 500,000/-

The applicant should certify the residence and annual income of the parents on the application form from the Grama Niladhari and the Divisional Secretary of the respective area.
