



## **SRI LANKA LAW COLLEGE SPECIAL ENTRANCE EXAMINATION ADMISSION OF STUDENTS FOR THE ACADEMIC YEAR 2027**

Applications are called for the Sri Lanka Law College Special Entrance Examination from those Graduates who have registered on 30.12.2020 or subsequently for the Bachelor of Laws Degree (LL.B.) in any of the foreign universities recognized by the Incorporated Council of Legal Education and have completed the relevant course.

The Special Entrance Examination will be conducted only in the **English Language** in June, 2026.

The Application for the above examination conducted by the Sri Lanka Law College should be filled **only in the English Language** and the details relating to access to the Application Form have been given in Number 06 of this notice. The application process will commence on 9<sup>th</sup> February, 2026 at 9.00 am and will close on 06<sup>th</sup> March, 2026 at 3.00 pm.

### **01. Eligibility for Entrance**

- I. Should be a citizen of Sri Lanka.
- II. Should have completed 17 years of age at the time of forwarding the Application. (Accordingly, only those whose Date of Birth falls on or before 06.03.2009 could apply).
- III. Should have obtained Two Credit Passes and an Ordinary Pass at one and the same sitting in the Sri Lanka General Certificate of Education (Advanced Level) Examination conducted by the Department of Examinations, Sri Lanka **or** in the General Certificate of Education (Advanced Level) Examination of The United Kingdom. (Please note that other qualifications relevant to this may also be decided by the Incorporated Council of Legal Education. A certified photocopy of the results sheet must be forwarded with the application).
- IV. Should have obtained a Credit Pass for English Language and a Credit Pass for Sinhala or Tamil in the Sri Lanka General Certificate of Education (O/Level) Examination or the National Certificate of General Education Examination or an examination recognized by the Incorporated Council of Legal Education of Sri Lanka as equal to the above examinations (Should forward a certified photo copy of the results sheet with the application) Please note that the Incorporated Council of Legal Education may also determine other relevant qualifications from time to time.
- V. Should have obtained a Bachelor of Laws Degree (LL.B.) from a recognized university in the United States, United Kingdom, Canada, Australia, Singapore and New Zealand (Must forward certified photocopies of the results sheet and Degree Certificate with the application). **Or;** A Law Degree (LL.B.) obtained from a university that ranks in the top hundred (100) in the Stream of law according to the Quacquarelli Symond (QS) World University Ranking or ranking recognized by the Council, as the case may be, within any one year during the term of study of such graduates (Must forward certified photocopies of the results sheet and Degree Certificate with the application).

The university awarding the Law degree under (V.) above must be a university recognized by the Incorporated Council of Legal Education.

**VI.** In addition to fulfilling the requirements in above (V), the applicant shall forward a certificate issued in the name of the applicant by an authorized authority of the relevant jurisdiction with regard to the eligibility of / permission for the applicant to practise as an Attorney - at - Law within the relevant jurisdiction where he has obtained the Law Degree, addressed to The Principal, Sri Lanka Law College, Colombo 12, Sri Lanka. This letter must be received at the above address prior to issuance of admission cards for the Special Entrance Examination. Candidates who fail to do so will not be permitted to sit for the examination.

## **02. Entrance Examination**

**I.** All applicants must appear for the Special Entrance Examination scheduled to be held in June 2026. The question papers for the Sri Lanka Law College Special Entrance Examination, are as follows:

01. International Trade Law	- Duration 01 hour. (Pass mark - 40)
02. Administrative Law	- Duration 01 hour. (Pass mark - 40)
03. Law of Contract	- Duration 01 hour. (Pass mark - 40)

The examination will be held only in English medium.

**II.** Each question paper consists of 03 questions and you must answer 02 questions from each question paper.

**III.** Those admitted will be selected in order of overall marks obtained.

**IV.** Each question paper is allocated 100 marks and the minimum mark required for each question paper to qualify for admission to the Law College is 40%.

**V.** The number of candidates to be selected will not exceed the number of students who qualified at the Sri Lanka Law College General Entrance Examination in the last academic year. (Government Gazette No. 2332/02 dated 15.05.2023)

**VI.** At the time of student registration, applicants who qualify for admission to the Law College through this examination will be admitted to the Sri Lanka Law College only on meeting the criteria stipulated for basic/educational qualifications required by the Incorporated Council of Legal Education.

## **VII. GENERAL CONDITIONS:**

Law graduates selected from the Special Entrance Examination will be admitted to the Sri Lanka Law College subject to relevant conditions determined by the Incorporated Council of Legal Education (Government Gazette No. 2332/02 dated 15.05.2023, Section 12(6)).

## **03. Law College Fee**

**I.** The duly completed Application Form published in the Sri Lanka Law College website together with the certified copies of educational certificates and the receipts of payment of Law College Fees must be submitted to the Student Records / Law Entrance Examination Unit on or before 06.03.2026.

- II. Law College Fee of Rs. 35,000/=** must be paid to the **Account Number 063020073300** (Hulftsdorp Branch) of the Hatton National Bank in the name of The Incorporated Council of Legal Education and the relevant receipt must be handed over with the application.
- III.** Applicant's name, National Identity Card Number and Telephone number must be stated clearly on the reverse of the receipts of payments for above (II.) Please note that, for no reason will the Law College Fee be returned / transferred for another examination. Keeping copies of the Receipt of Payments in possession will be useful.

#### **04. Examination Admission Card**

- I.** On the basis of that only those who meet the qualifications specified in the Gazette notification have applied, the Sri Lanka Law College will issue examination admission to the candidates who have submitted duly completed applications along with the relevant receipt, paid the prescribed examination fee on or before the last date for receipt of applications, and are within the age limit specified in the notification. As soon as the examination admission cards are issued, a notification will be published on the website of the Sri Lanka Law College to that effect.

These admission Cards will be sent to the personal email address specified in each examination candidate's examination application form.

- II.** In proof of the identity of the Examination Candidate, any of the following documents would be accepted.
  - i. National Identity Card
  - ii. Valid Passport
  - iii. Valid Sri Lanka Driving License

Furthermore, candidates should enter the examination hall without covering their faces so that their identity can be verified and without covering their ears so that it can be confirmed that they are not wearing electronic communication devices. Candidates who do not do so will not be admitted to the examination hall. Furthermore, they should remain without covering their faces and ears from the moment they enter the examination hall until the examination is concluded and they leave it.

- III.** The Admission Card with the certified signature of the candidate must be submitted to appear for the examination.
- IV.** The Examination Candidates are bound by the rules and regulations imposed by the Incorporated Council of Legal Education with regard to the conduct of examinations and release of results. Any violation of the said rules and regulations, may give rise to a penalty imposed by the Incorporated Council of Legal Education.
- V.** Issuance of an Admission Card to a candidate shall not be considered as acceptance of the candidate eligibility to appear for the examination.

## **05. Rejection of Application**

Your application may be rejected for the following reasons. Therefore, pay serious attention prior to handing over the application.

- I.** Submission of incomplete or incorrect application.
- II.** Not attaching the duly Credited Receipts with the application.
- III.** Failure to submit the originals of the Educational Certificates when requested to do so by the Sri Lanka Law College.
- IV.** Non fulfillment of Educational Qualifications at the time of forwarding the application.

### **Note**

**Penalty for false information:** The applicant shall comply with the exam instructions, conditions and rules and regulations. If noncompliance is revealed, at any time before, in the course of or after the examination, his / her candidacy may be cancelled.

## **06. Method of Application**

- The Application Form can be downloaded from the Sri Lanka Law College website ([www.sllc.ac.lk](http://www.sllc.ac.lk)) until 06.03.2026.
- Also, the completed Application Form together with certified copies of Educational Certificates and the Receipt of Payment must be handed over on or before 06.03.2026 to the Student Record/ Law Entrance Examinations Unit of the Sri Lanka Law College.
